BE IT RESOLVED by the Board of Commissioners of the South Pittsburg Housing Authority that said board has reviewed and approved the operating budget for fiscal year ending June 30, 2022 and has found:

- 1. That the proposed expenditures are necessary in the efficient and economical Operation of the housing and the purpose of serving low income families;
- 2. That the financial plan is reasonable in that:
 - a. It indicates a source of funding adequate to cover all expenditures;
 - b. It does not provide for use of federal funding in excess of that payable under the provision of these regulations (24 CFR 990).

Attorney Willis stated that she would send those requests back to the City's Attorney.

Lisa Bradford presented the board with two different options for Commissioner training that she believes would be very beneficial for the board to attend, both a virtual training and a training located in Nashville in August.

Lastly, Lisa Bradford presented the board with some diagrams of the exterior renovations that is in the works as the next Capital work to begin within the developments, beginning at Old Jasper Road.
