Chairman Bobby Vinson called for a motion to approve the board agenda for the March meeting. The motion was made by Commissioner Charlene Hudson and seconded by Commissioner Lyne Garman. All were in favor- Aye and the motion carried.

Chairman Bobby Vinson stated that the board would forgo the reading of the minutes from the previous meeting. Chairman Vinson called for a motion to approve the minutes from the previous meeting. The second item of new business was the SPHA request for payment of \$150.00 for each SCAC rentals. There was much discussion regarding this topic and it was asked by the chairman that Director Cross get together what the monthly expenses for the SCAC and the possibility of using door codes for the SCAC and send that to the board before any

decision is made; therefore, this request will be tabled until the June 2023 meeting and the Commissioners have had time to look over the monthly expenses.

## **Commission Reports, Comments, Questions:**

Chairman Vinson asked questions regarding vendors paid by the South Pittsburg Elderly Housing under Commission questions. Due to the cost of the phone systems, Chairman Vinson asked Director Cross to look into get a less expensive dedicated phone line for the elevator from other vendors, rather than AT&T. Director Cross agreed to do so.
